The Educational Opportunities Act of 2006 created Iowa's first school choice program. Donors to School Tuition Organizations (STOs) receive a 75% tax credit, and STOs in turn give out those funds as tuition grants to lower-income students to attend one of Iowa's accredited, nonpublic schools. Individuals, S-Corporations, LLCs, Partnerships, C-Corporations, and certain estates are all eligible to donate to this program and receive this generous tax credit.
